MINUTES OF THE TOWN COUNCIL MEETING HELD ON MONDAY 28TH JANUARY 2019 IN THE TOWN HALL

County Councillor

County Councillor Groskop wished Councillors a happy new year and talked about Somerset County Council's finances several phone calls she had received regarding parking and speeding and informed Council that the Highways Department will now empty gullies on request rather than the 4 year cycle.

South Somerset District Councillor

District Councillor Winder talked about the transformation of SSDC which will cause lots of problems in the next 6 months. He talked about the Wincanton Strategy consultation at the Memorial Hall, and urged Councillors to submit their views. There are problems at the Vedler's Hay site concerning a wall and the SSDC Savour the Flavour event will be held in Wincanton March 30th 2019.

0485 CHEQUE LIST

On a proposal from Councillor Ellard and seconded by Councillor McLarnon, the cheque list was approved. Councillors Ellard and Hinks will sign the cheques Tuesday 29th January 2019. Council noted the quarterly accounts.

0486 CEMETERY REGULATIONS

On a proposal from Councillor Ellard, seconded by Councillor H Smith, Council voted unanimously to increase the height of the memorial stone for the Garden of Remembrance to 4 inches.

0487 HIGHWAY ISSUES

Councillor Hinks reported the parking problem leading to Balsam Fields from South Street. Councillor Cook asked why the grit bin at Cale Way is on the road.

Councillor D Smith reported the bad signage at Thornwell Lane and the road markings at Pines Close.

0488 FUNDING FOR THE SKATEPARK

Council discussed the process of applying for a Public Works Loan via the National Association of Local Councils. Councillor Ellard proposed to apply for £150,000 and that Council entrust the Clerk with engaging with NALC, preparing documentation for a public consultation and reporting back to Council. Councillor Hinks seconded the proposal and Council voted unanimously to accept the proposal. Council agreed unanimously that Maverick Industries will carry out the works as per their quote.
